Declares moreover to renounce to claim any compensation which could be claimed in the future against the alleged association, exonerating it from every liability and from all the legal actions related to it, lawsuits and any other kind of legal and judicial procedures related to the risk of injuries, compensation of damages by people and/or goods of third parties, damages to equipment and the risk of loss of personal belongings for theft or any other reasons except for mandatory limits imposed by laws, and from any and every liability committed by a minor.

ADVISORY NOTICE IN ACCORDANCE WITH ARTICLE 13 GDPR 679/2016 AND CONSENT TO THE PROCESSING OF PERSONAL DATA

In accordance with the articles 13 and 14 del UE Regulation 2016/679 related to the General Data Protection Regulation ("GDPR"). We inform you about the following:

Purpose and legal principle of the processing of personal data. The Association will process your personal data and the ones of your minor(s), which you provided us, exclusively for the execution of the request and the service that you asked for and for the fulfillment of legal obligations. The legal principle is represented by the consent (article 6 comma 1 lett. a GDPR) o by a legal obligation (article 6 comma 1 lett. c GDPR).

Modality and principles of the processing. The processing of personal data will be conducted respecting the GDPR and the D.Lgs. n. 196/03 ("Code for the protection of personal data"), as well as following the principles of honesty, transparency, adequacy and jurisdiction, and executed by authorized personnel of the Association and employing appropriate protection measures in order to guarantee the data security and privacy. There won't be any automatic decision process.

Need for the use of personal data. The personal data are necessary for the organization of the requested service. Whereas the service consists in the participation to events, classes or activities of the Association, the data could be acquired and published in the organization's website, in the social networks and on the informational material of the Association, pictures, photographic images or videos of your minor(s), only after obtaining your explicit and separated consent.

Communication and external transfer of the data. The data won't be communicated to third parties nor be transferred to extra EU beneficiaries. The data could be used with the modality indicated above and only with your consent for the images of your minor(s).

Period of the data retention. The duration of the processing of the data will not be superior to the one necessary to accomplish the purposes (fulfillment of the service and execution of the request) for which they were collected which is indicated above, except for the legal or fiscal or accounting obligations or the existence of needs tied to the legal protection of the Association, with the exclusion of communication to third parties and in any case applying the principles of proportionality and e minimization.

Rights of the person involved. As involved party, all the rights specified by the articles. 15 - 20 GDPR are guaranteed, among which the right to access, correction and cancellation of data, the right of limitation and opposition of the data processing, the right to revoke the consent to the processing of data (without the prejudice of the validity of the data processing based on the previous consent before the annulation), as well as the right to present a claim to the Guarantor of the Protection of Personal Data in case you believe that the processing of your data violates the GDPR o the Italian norms. These rights can be exercised through written communication to be sent by email, certified email, fax or registered letter at the headquarters of the Association. Owner of the data processing.
